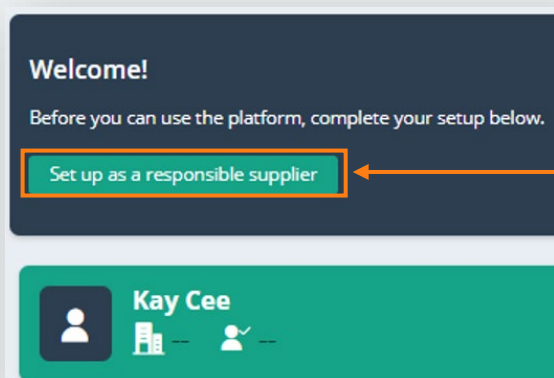


EXISTING RESPONSIBLE SUPPLIER

As you have an existing responsible supplier registration, the current Authorised Officer must set up the business in the new EESS platform and then invite team members to join the platform

Once you have completed creating your individual account (see [Setting up yourself on the EESS Platform in the Learning guides](#)) and selected how you intend to use the platform, when you log in again you will see a 'Welcome' message top left of your screen. Below this will be a button to set up your business

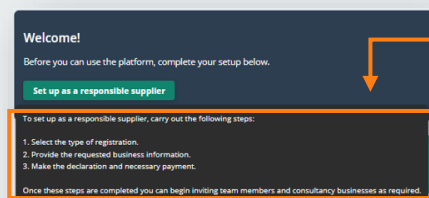
Note: once you as Authorised Officer have completed setting up your business in the EESS platform, you can assign the platform role of Business Admin to one of your team members who can then manage the system.



This button will reflect the intent to use the platform as previously selected

If you are an EESS registered Responsible Supplier who was using the legacy Registration database you, the following steps will apply:

1. Enter the requested business information
2. Authenticate Business
3. Verify
4. Type of registration - EESS / EESS&ACMA / ACMA
5. Business address
6. Review
7. Make the declaration



Hovering over the button will remind you of the key next steps to set up your business

To start setting up your business

- Click on the button

STEP 1: Enter the business information


- Enter country
- Enter ABN/NZBN* and click the **Refresh** button

Note: if New Zealand is selected, your IRDN will be required

*ABN/NZBN: The Australian or New Zealand Business Number associated with the Responsible Supplier.

IRDN: Inland Revenue Department Number for New Zealand companies.

Note: It is mandatory for a responsible supplier to be based in Australia or New Zealand and have an ABN or IRDN





STEP 2: Authenticate

At the point the ABN/NZBN is refreshed (IRDN in the case of New Zealand being the country selected), the system will look to see if your business exists in the EESS Platform, and you will be required to confirm your business

This will ensure your data migrated from the legacy Registration database is linked to your business set up as a Responsible Supplier in the EESS Platform

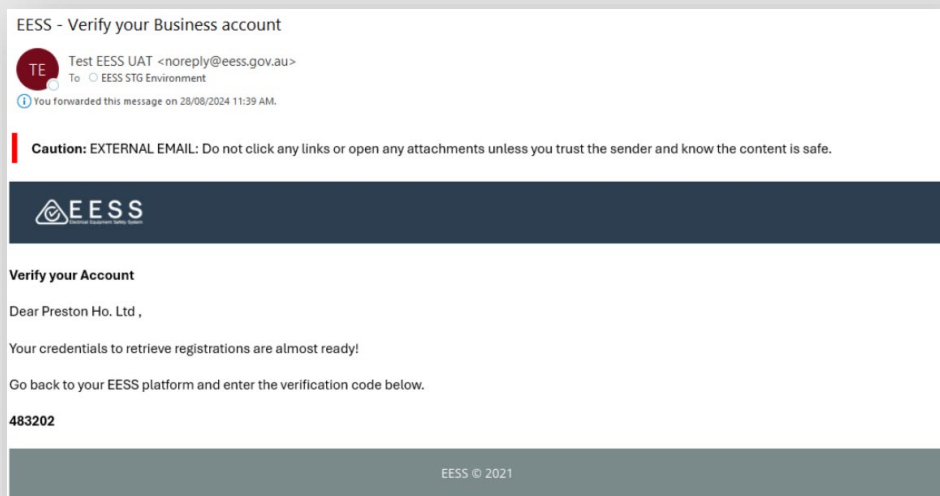
NOTE: The Breadcrumbs at the top of the screen that will show you where you are in the process



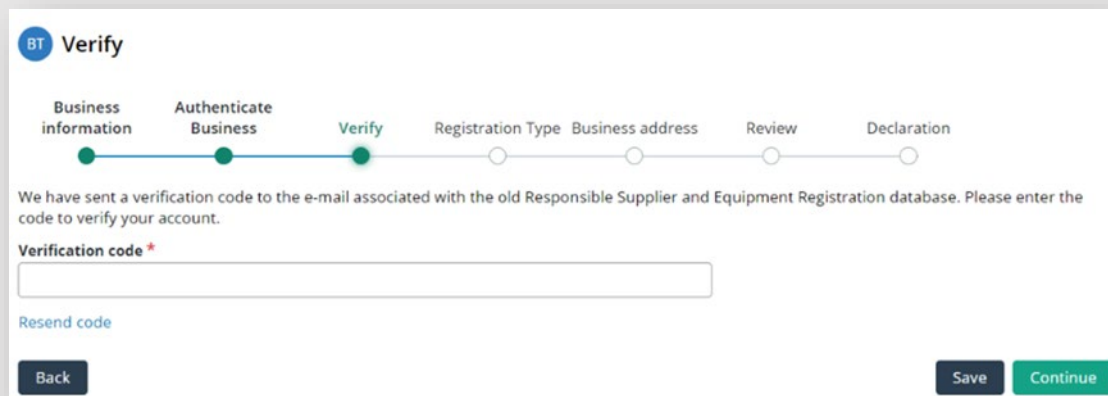
- Enter your Responsible Supplier Number, that is 'EXXXXX', in the field provided to authenticate your business
- Click the **Continue** button

STEP 3: Verify

A verification code will be emailed using the business email address associated with your Responsible Supplier registration in the legacy Registration database



- Enter the verification code in the field as requested



- Click the **Continue** button to go to the next screen

STEP 4: Select Registration Type

It is important to read all the notes that appear as the information may vary depending on your selection


- Click the type of registration you intend to perform in EESS and the EESS platform




STEP 7: Declaration

You will be asked to make a declaration confirming the equipment supplied is electrically safe and meets all relevant electrical safety standards. A Responsible Suppliers Declaration is a declaration of compliance with either the EESS and/or the ACMA schemes, made when registering on the platform

Please read the Declaration carefully

Note: the Declaration screen will differ depending on the Registration Type you selected in Step 2. The example below is for EESS and ACMA registration type

I declare that:

(1) I, A Key, am the authorised officer who has been authorised to make this declaration on behalf of EXAMPLE PTY LTD.

(2) This declaration relates to electrical equipment for which EXAMPLE PTY LTD is the manufacturer in Australia or New Zealand or is the entity who is the importer of the equipment into Australia or New Zealand.

(3) All electrical equipment supplied will be electrically safe and meet relevant standards at the time the equipment is imported or manufactured. Specifically, that:

(a) each item of a type of level 1 in-scope electrical equipment when sold by the responsible supplier will—

(i) meet the relevant standard for the type as in force at the time the item was manufactured in Australia or New Zealand, or imported into Australia or New Zealand by the responsible supplier; and

(ii) be electrically safe.

(b) each item of a type of level 2 or level 3 in-scope electrical equipment when sold by the responsible supplier will—

(i) be registered in the national register;

(ii) meet the relevant standard for the type as at the time the item was registered in the national register; and

(iii) be electrically safe.

(4) All equipment supplied will comply with the EESS and relevant electrical safety laws.

(5) There is a current certificate of conformity for each plug, flexible supply cord or appliance connector, as defined in AS/NZS 4417 (Regulatory compliance mark for electrical and electronic equipment), sold for use with the item (where applicable). Note: cords may have HAR mark in lieu of a certificate of conformity.

(6) When registering level 2 or level 3 in-scope electrical equipment on the national register the Responsible Supplier's authorised officer or authorised representative will make an equipment declaration.





Registration types 'EESS & ACMA and EESS only are required to pay annual renewable fees

NOTE: no payment is required for ACMA Only applicants. If you are declaring for ACMA only and see this payment page, do not proceed. Go back and unselect EESS declaration

The first screen shows the amount owed

- Click on the **Submit** button to go to the Select Payment Method screen
- Select the payment method *





*2 payment methods:

- BPoint uses Credit or Debit card to make an immediate payment
- BPAY applies a Biller Code and allows payment later through your bank channel

BPoint requires you to enter your Credit or Debit card details

- Click on the Pay button

BPoint Payment is complete

- Once you receive the Payment Successful message you can click on **SUBMIT APPLICATION** to complete your Responsible Supplier Registration
- You will receive the following messages:
 - Confirmation that you have been set up as a Responsible Supplier
 - A message to say that you are registered as a Responsible Supplier stating the registration type. The message will ask you to log off and log on again
 - An email confirming your registration which will have the declaration and tax invoice attached

Note: All EESS fees do not include GST and once payment is processed, a receipt will be issued



Log off the EESS Platform and process the payment with your Bank

- Please initiate BPAY payment through your bank channel only after you have clicked on the 'Confirm' button on this screen. The Biller Code, Reference Number, Payment Due Date and the exact Payment Amount will still be visible to you after you click the 'Confirm' button.
- The payment needs to be settled within the Payment Due Date on this screen. BPAY payments will be not available after the expiry of this period. You will need to go back to the individual case of each Items and add them back to payment cart and initiate a new payment.




